Under the Turkish Criminal Code, people who are elected to temporarily or permanently carry out public duties are considered Public Officials and the range of people to whom bribery regulations is applied is not limited to Public Officials.

The table below provides examples of people who are considered Public Officials and individuals who are not Public Officials but who may be subject to bribery-related regulations within the range of the Turkish Criminal Code.
